

Equipment shall not be fitted with video or audio recording devices and must have all sound muted while in use in the courtroom. The equipment may not be connected to the Judiciary's computer network within the Courthouse.

The Clerk of the Court shall ensure a copy of this order is provided to appropriate security personnel and to each person authorized use of a notebook computer while in the Courthouse.

This Order replaces General Order TPA-2004-5, which shall be archived.

This Order is effective June 1, 2004 and shall expire at midnight on July 1, 2004.
