**ORDER THANKING RETIRING MEMBERS OF  
LOCAL RULES LAWYERS' ADVISORY COMMITTEE  
AND APPOINTING SUCCESSORS**

In the Order Institutionalizing Local Rules Lawyers' Advisory Committee, No. 95-0005-MIS-TPA, entered on June 29, 1995, the Court established its Local Rules Lawyers' Advisory Committee, set forth the committee's charter, appointed the members of the committee, and established the manner in which the membership of the committee would be appointed. The Court notes that, pursuant to those provisions and this Court's last Administrative Order on this subject (Administrative Order FLMB 2004-1), the terms of three members of the committee extended to June 30, 2004 or until their successors are appointed, two members' terms extended to June 30, 2005 or until their successors are appointed, and three members' terms extended to June 30, 2006 or until their successors are appointed; successors have not yet been appointed.

For continuity, the judges of the District have decided to replace at this time only those three members whose terms were scheduled to expire in 2004, and to reappoint, to shortened and staggered terms, the remaining members who are willing to serve.

Accordingly, based on, and in consideration of, the recommendations of the judges resident in the Jacksonville, Orlando, and Tampa/Ft. Myers divisions, it is hereby

**ORDERED:**

1. The Court expresses its gratitude to the members of the committee whose terms were scheduled to expire on June 30, 2004, Cynthia C. Jackson, from the Jacksonville Division, Ann-Marie Bowen, from the Orlando Division, and Bernard J. Morse, from the Tampa Division, for their able and beneficial service.

2. The Court appoints the following persons as successors to the members of the committee whose terms were scheduled to expire on June 30, 2004: Bradley R. Markey, from the Jacksonville Division; Bradley M. Saxton, from the Orlando Division; and Donald R. Kirk, from the Tampa Division; each to serve for a three-year term, that will expire on June 30, 2010, or until their successors are appointed.

3. The Court reappoints Roberta Colton and Angela Stathopoulos, each for a one-year term that will expire on June 30, 2008, or until their successors are appointed.

4. The Court reappoints Richard R. Thames, from the Jacksonville Division, W. Glenn Jensen, from the Orlando Division, and Michael C. Markham, from the Tampa Division, each for a two-year term that will expire on June 30, 2009, or until their successors are appointed.

5. Roberta Colton will remain as Chair of the committee.
