Introduction

This guide contains the preferred style practices for all users of the CM/ECF application in the Middle District of Florida. Style consistency is the key to efficient searches in CM/ECF. Queries require very exact matches on search data including punctuation, abbreviations, and upper or lower case characters.

Style Conventions for Names

These style conventions apply to all names entered in the CM/ECF application.

Use upper and lower case characters for all names and capitalize the first letter in a proper noun.

Wallace D Smith

United Services Fidelity and Guaranty

Use only the following punctuation;

Hyphens (-)

Apostrophes (')

Use single spacing between all names and following initials.

J.J.Jones

Smith Inc

C W Bradford Ltd

When typing names that have upper and lower case letters or hyphens enter the name as it appears on the document.

Patrick MacDougal

Kathleen O'Brien

Mary Smith-Baker

If a party has multiple names such as Robert Kramer Johns Martin, add the extra names in the Middle Name

box.

Martin

Last name field:

Middle name field: Kramer Johns

First name field: Robert

Business names should be entered entirely in the Last Name box. Do not use the First Name or Middle

Name box when entering business names.

Do not use the ampersand sign (&) for "and" unless it is part of a company name on the petition or

pleading. Use single space on both sides of the ampersand sign (&).

Adding Parties

Debtors

Company names beginning with the words "The, A, or An" should be entered beginning with 'The, A or An."

Enter The Cookie Company as;

Last name field: The Cookie Company

First Name Field: Leave blank Middle name field: Leave blank

Enter A Toy Store Inc as;

Last name field: A Toy Store Inc First name field: Leave Blank Middle name field: Leave Blank

Title, Prefix and Suffix Tips

Titles and Prefixes such as;

1 Dr

2 Rev

Should be entered in first name field.

Enter Rev Daniel Hoseman as;

Last name field: Hoseman First name field: Rev Daniel

Enter Dr David Smith as;

Last name field: Smith First name field: Dr David

Suffixes such as;

MD DDS Sr Jr

Should be entered in last name field.

Enter Roger Thomas DDS as:

Last name field: Thomas DDS

First name field: Roger

Enter Daniel A Hasioka MD as:

Last name field: Hasioka MD First name field: Daniel Middle name field: A

Plaintiffs and Defendants

Do not add addresses in the Party Pick List screen for plaintiffs or defendants unless the plaintiff or defendant is pro se. If pro se, add the address in the Party Pick List screen

Do not add titles for plaintiffs and defendants.

Parties

When docketing documents that requires a party to be selected from the Party Pick List; select party from pick list only if you find an exact name match. If an exact match is not found, select add/create new party to record.

Style Conventions for Addresses

These style conventions apply to all debtor and creditor addresses entered in CM/ECF.

The party name and address **must** be a minimum of (2) lines with the second line containing the city, state and zip code.

The party name and address **must** not exceed five (5) lines.

When there is a street address as well as a mailing address for a debtor add only the mailing address.

When needed, use the second and/or third line of the address for building name, suite number, floor, firm name, or attention.

The city, state, and zip code must be the only information on the last address line.

The preferred format for telephone numbers is (210) 261-3851.

Foreign Address

Foreign addresses must have the full name of the post office and country of destination printed in capital letters.

The country name or APO destination must be the only information on the last address line.
