

## **Rule 9027-1 [Amended]**

### **REMOVAL/REMAND**

(a) ***State Court Record to be Filed with Notice of Removal.*** The party filing a notice of removal of a claim or cause of action under 28 U.S.C. § 1452 and Fed. R. Bankr. P. 9027 shall file with the notice of removal copies of all papers then on file in the state court.

(b) ***Operative Pleadings and Other Relevant Papers to be Separately Docketed.*** In addition to filing a complete copy of the state court record, within seven days of filing the notice of removal, the party who filed the notice of removal shall also file with the Court, as separate docket entries, the operative pleadings, substantive rulings, and any pending motions and responses included in the state court record.

#### ***Notes of Advisory Committee***

##### ***2015 Amendment***

This amendment requires the removing party, in addition to filing the state court record with the notice of removal, to also file the operative pleadings, etc. as separate docket entries.

##### ***2004 Amendment***

This amendment corrects the Bankruptcy Rules citation to that of the currently used citation.

##### ***1997 Amendment***

This amendment conforms the existing Local Rules to the uniform numbering system prescribed by the Judicial Conference of the United States and to the model system suggested and approved by the Advisory Committee on Bankruptcy Rules of the Judicial Conference's Committee on Rules of Practice and Procedure. In renumbering the Local Rules to conform to the uniform numbering system, no change in substance is intended. This amendment was effective on April 15, 1997.
