**ORDER GRANTING MOTION FOR WAGE DEDUCTION ORDER**

THIS CASE came before the Court upon the Debtor’s Motion for Wage Deduction Order (Doc. No. \_\_\_) (the “Motion”). The Court, being fully informed in the premises, finds that the request has merit and should be granted. Accordingly, it is hereby

**ORDERED:**

1. The Motion (Doc. No. \_\_\_) is GRANTED.

4. This Order shall remain in effect until further order of this Court or until any of the following occurs:

- a. Filing by Chapter 13 Trustee of Notice of Completion of Chapter 13 Plan;
- b. Entry of an order vacating this Order;
- c. Entry of an order converting this case to another chapter of the Bankruptcy Code;
- d. Entry of an order dismissing this Chapter 13 case; or
- e. Entry of an order discharging debtor(s) after completion of the Chapter 13 Plan.

**[Moving counsel's name]** is directed to serve a copy of this order on interested parties who do not receive service by CM/ECF and file a proof of service within three days of entry of this order.
