**ORDER REGARDING ATTENDANCE AT HEARINGS**

THIS MATTER comes before the Court *sua sponte*. Based on the large number of interested parties in this case, and the broadcast policy of the Judicial Conference of the United States,<sup>1</sup> the Court modifies its current hearing procedures<sup>2</sup> in these cases as provided below.

***Parties Who Only Want to Observe***

All parties may attend any proceeding in person. However, the Court waives the requirement to file a motion for leave to attend non-evidentiary hearings remotely for those interested parties who want to observe a hearing. Such parties in interest who solely wish to observe a hearing are permitted to observe by audio only and must register to attend the hearing through CourtSolutions<sup>3</sup> or such other third-party audio service that may be arranged by Debtor's counsel. Please note, CourtSolutions is a third-party service and may charge the attendee a fee.

***Members of the Public or Press***

Members of the public or press may attend any proceeding in person. Members of the public or press may also have remote audio access to any *non-trial* proceedings that do not involve witness testimony, by registering through CourtSolutions or such other third-party audio service that may be arranged by Debtor's counsel.

***Pro Se Parties and Attorneys Who Want to Actively Participate***

The Court waives the requirement to file a motion for leave to attend hearings remotely by party participants<sup>4</sup> who (1) do not anticipate making substantive arguments, introducing evidence or examining witnesses, or (2) have worked diligently with opposing counsel as necessary to resolve contested issues prior to the hearing and have a good-faith belief the matter will be resolved or continued to a further hearing. Instead, until any such time as the Court may otherwise direct, participants who meet the above criteria and desire to appear remotely for a hearing must register to attend by Zoom no later than 3:00 p.m. (Eastern Time) the business day prior to the hearing. Participants attending by Zoom pursuant to this Order must log on to the hearing no less than 15 minutes prior to when the hearing is scheduled to begin to permit Court staff to take appearances of record before the hearing begins. **All other active party participants must appear in person.**

***Hearing Notices***

When attorneys are directed to prepare a Notice of Hearing,<sup>5</sup> paragraph 2 of the notice should be revised to:

The Court has modified its current hearing procedures in this case. Parties and interested persons should refer to the *Order Regarding Attendance at Hearings* (Doc. No. 98) entered in this case on February 5, 2026 to determine whether they may appear remotely and the means by which their attendance is permitted.
